Note: California, Connecticut, Indiana, and New York implemented long-term care partnership programs several years ago. They are often referred to as the "original partnership" states. These programs differ from the new partnership programs currently being established in other states in response to the federal Deficit Reduction Act (DRA) of 2005. As a general rule, training requirements for "original states" does **not** follow the NAIC model adopted by most new partnership states. Producers who take NAIC based training will **not** meet the requirements for any of the four original states. Producers who complete partnership training in one of 4 the original states will **not** meet the requirements for any the new states. **!ICT:** Agents must first complete a prerequisite online course, approved by the partnership program and then 4 hours of classroom instruction conducted by partnership program staff. **IN:** Agents must take 8 hours of initial training and 5 hours of ongoing training every 2 years. To sell partnership policies, agents must **also** take 7 hours of partnership training in the classroom. **NY:** Agents must complete 8 hours of training, consisting of a 4-hour online course followed by 4 hours of classroom instruction offered by the NY partnership program.04/10/12
